<u>RESOLUTION NO. 2011-07</u> SALE OF SCRAP METAL POLICY

On motion of Jim Whipple, seconded by Wirt Bane a scrap metal policy is hereby approved, voted and carried.

SALE OF SCRAP METAL POLICY

WHEREAS, the Village of Lyndonville Department of Public Works routinely accumulates scrap metal, and

WHEREAS, the Village Board has determined that selling the scrap metal periodically and depositing the funds in the General Fund of the Village is in the public interest, and

WHEREAS, Village Law section 1-102(1) authorizes a village to sell its scrap metal, and

WHEREAS, a village is under an obligation to obtain the best possible price for the scrap metal which it sells, and

WHEREAS, a village may sell its scrap metal by auction sale, sealed bid, or by obtaining various quotations so that the best possible price can be determined so that the scrap metal may then be sold for such price at private sale, and

WHEREAS, the Village Board wishes to set forth in writing its policy relative to the sale of scrap metal,

NOW, THEREFORE, BE IT RESOLVED as follows:

- 1.) To be deemed surplus scrap metal, one of the following criteria must be
 - a.) It has been condemned for use by the health department or other regulatory entity of competent jurisdiction.
 - b.) It is damaged or worn such that it is not economically feasible to repair.
 - c.) It has been or is scheduled to be replaced.
 - d.) It is outdated or obsolete.

met:

- e.) It cannot be repaired in a cost effective manner for a different or additional use.
- f.) It is excess and will not be used.
- g.) It is functionally obsolete.

2.) Prior to a sale, the Village DPW Superintendent shall determine an estimated fair market value of the scrap metal to be sold based upon current market factors.

3.) The Village Board shall adopt a resolution declaring the scrap to be surplus, specifying the manner in which the scrap is to be sold and delegating the sale task to a specific official as hereinafter set forth.

4.) Proceed with the sale as authorized by the Village Board in a commercially reasonable manner. Sale may be by auction, private sale, or sealed bid, depending on the type and amount of scrap metal and upon the fair market value as estimated by the DPW Superintendent.

- 5a.) Estimated value of \$0 to \$250, private sale within limits determined by the Village Board. Sale to be made by DPW Superintendent with sign-off by Mayor. Proceeds to be by check or money order; no cash will be accepted.
- b.) Estimated value of \$250 to \$1,000, sale may be by sealed bid, advertised sale, or private sale obtaining two quotes within fair market value limits set by Village Board. Sale to be by Mayor or DPW Superintendent with sign-off by Mayor. Proceeds to be by check or money order; no cash will be accepted.
- c.) Estimated value in excess of \$1,000, a Village Board Resolution requiring advertisement by sealed bids and acceptance of highest bid by Village Board.
- 6.) All checks or money orders shall be payable to the Village of Lyndonville.
