PRIVILEGE OF THE FLOOR:

Mr. Martino stated that NYS now requires permits for parades on State highways. Mr. Martino asked who completed the permit for the Memorial Day parade. Superintendent Woodworth stated a permit wasn't needed for parades that are ten (10) minutes or less, the Village just is responsible for regulating the parade. Trustee Whipple added that previously he felt that the Lions Club should take the lead in completing the Parade Permit. However Trustee Whipple would like to see the Village of Lyndonville sponsor the 4th of July parade and complete the necessary permit application. Trustee Whipple also noted that the Lions Club doesn't have the man power needed for directing traffic and setting up barricades. Superintendent Woodworth added he was sure the Village has the necessary insurance coverage of five (5) million in liability coverage and ten (10) million in auto. Also the Village supplies the Auxiliary Police officers. Per Superintendent Woodworth a parade route, a detour route as well as NYS DOT State approved signs and barricades would be needed. Mayor McAvoy asked if the Village currently has the required signs. Superintendent Woodworth stated he was sure between the Town of Yates, Town of Ridgeway and Orleans County he would be able to get the necessary signs. Clerk-Treasurer Woodworth noted that she requested seven (7) Auxiliary Police this year plus Officer Larkin will be assisting Officer Riemer. Mr. Martino advised he will get a point of contact from the Lions Club to assist with the process. Superintendent Woodworth added this may mean some overtime for the DPW as in years past they haven't been involved in the day of setup. He was sure the Town of Yates would assist the DPW in getting the signs and barricades setup ahead of time. Trustee Woodward Jr. noted that he doesn't believe that Fire Department can assist in traffic control as when they did the Tour for the Cure they were told they couldn't assist as it wasn't their function. Trustee Tuk added this may add more for the Village with the Village sponsoring the parade.
