To The Medina Village Board:

Orleans County is in receipt of Resolution No. 2 of April, 2015. Thank you for passing along what appears to be the collective opinion of the Village of Medina Board of Trustees.

After reading the resolution, it is clear that there are a number of misconceptions and factual errors that the county can help address to better inform the community about the issues raised in the resolution. The purpose of this communication is to address those issues in hopes of once again opening the door to a larger conversation about cooperation, shared services and innovative service delivery models across the county. This letter will identify statements directly from the resolution and address them one by one.

*"WHEREAS, all municipalities should fairly share the benefit from the growth in the sales tax revenue in good economic times, and have fairly shared the burden from declining county sales tax revenue during difficult economic times;"*

This statement assumes that the current sharing formula is unfair and pre-supposes that this assumption is self evident. It is not. In fact, when examining statistics from 2013 on New York State Counties there are fourteen counties under 50,000 in population like Orleans County and four in the Finger Lakes Region of which we are a part. Orleans County ranks as the fourth highest for the percentage of sales tax shared. However, two of the fourteen counties have cities (Cortland and Montgomery) that are able to preempt and capture much larger shares of the overall revenue. Dropping those two counties lifts Orleans County to number two in the state among small counties without a city in terms of sharing sales tax, second to Schuyler County, the home of Watkins Glen International Speedway.

Delving further into those same statistics, it's evident that eight of the fourteen counties do not share sales tax revenue at all, zero percent. So, the majority of small counties in New York State do not share sales tax. Orleans County is the only county in the Finger Lakes Region under 50,000 in population that does share sales tax revenue.

The statement that *"all municipalities have fairly shared the burden from a declining county sales tax growth"* is not factual either. In reality, Orleans County missed the budget number in 2013 by \$363,831.94, 2010 by \$325,527.16 and 2009 by \$522,035.79, yet the amount shared with the towns and villages remained unchanged. Villages and towns in fact faced none of the burden of faltering sales tax revenue.

Another relevant fact is that when villages and towns around the county have uncollectible real property taxes, it is the county that also assumes the burden of paying the real property taxes to the villages and towns, making them whole as the county works to return the property to the tax rolls and assumes any losses that may result.

Furthermore, Orleans County assumes the burden of the local share of community college charge backs which is identified as a town expense by state statute. The community college expense has grown at a breathtaking pace over the last decade from \$694,823 in 2005 to \$1,664,475 in 2014, an expense absorbed solely by Orleans County. The county assumes the full of the burden in all three instances.

*"WHEREAS, the Governor and the New York State Legislature enacted a property tax cap of two percent (2%) in 2011 for all local governments without any mandate relief, adding to the difficulty for local government to meet its fiduciary obligations;"*

This statement certainly applies to county government as the main provider of state mandated human services programs. It is less clear what significant mandates that a village faces as it is voluntary by nature, formed by the citizenry. Aside from commitments to the New York State Retirement system, the county is not aware of other mandates faced by the Village of Medina. Additionally, the retirement system has seen some significant reform packaged as mandate relief that sets the table for long term savings. The county by contrast saw brutal growth of eight major state mandated human services programs of 48% or \$5.9 million over the ten year period between 2005 and 2014 outpacing the growth of sales tax over the same period by \$255,172.77.

In addition, your proposal to change the sales tax sharing formula has significant implications to the county tax cap availability, cutting in half for a decade. This hardly seems appropriate for the municipality bearing the vast majority of state mandates in support of the community, to face the additional fiscal stress requested.

*"WHEREAS, the sales tax revenue distribution formula as enacted by the county, disproportionately impacts all villages and towns, and has resulted in many municipalities having to cut services and increase property tax levy to offset loss of County sales tax revenue, and, in many cases require municipalities to override the mandatory two percent (2%) tax cap;"*

It is not clear how the formula in question can disproportionately impact every town and village at once or how slight adjustments in a municipality's share of sales tax can have such catastrophic results as described. Further, the idea that service cuts, property tax increases and overrides are somehow a direct result of the sales tax sharing formula is an acrobatic conclusion to draw.

Additionally, town and county taxes are presented on the same bill, how does moving revenue from one section of the bill to another actually provide a benefit to the taxpayer? It certainly does not present the taxpayer a financial advantage to adjust the percentage paid from one municipality to another. Isn't that the purpose of fundamental changes like this?

Orleans County has cut spending by 19.4% between 2014 and 2015 and divested or cut the Certified Home Health Agency, the Continuing Day Treatment Program and the Villages of Orleans (county nursing home). Further, the county reduced total staff by 221 positions or 34.6% of all positions. There is a constant evaluation of our operations and commitments to determine their viability. There is no municipality in this county more seriously impacted by service cuts than the county and it isn't close. Orleans County has taken these challenges very seriously and has met them head on in a way that has distinguished us from our peers as one of the Top Five Best Run Counties in New York State according to an article in the New York State Bar Association publication Municipal Lawyer.

Once again the county sincerely stands ready to open the door to a larger conversation about cooperation, shared services and innovative service delivery models that provide taxpayers of this county from all municipalities the best, most competent and most efficient government that we can provide for their investment in us. The county looks forward to a productive, respectful and cordial working relationship with the Village of Medina and all Orleans County municipalities in the future.

- Town of Carlton Resolution - Nora Initiative in supporting Congressman Collins fight against IJC Plan 2014

WHEREAS, In June of last year, the International Joint Commission introduced Lake Ontario St Lawrence River Plan (Plan 2014); and

WHEREAS, the U.S. Department of State is currently conducting an inter-agency review of Plan 2014, seeking information specifically from the Environmental Protection Agency, the Army Corps of Engineers and the Department of Transportation; and

WHEREAS, Plan 2014 will have a devastating impact on the communities along the Lake's southern shoreline. The Plan will increase the frequency of raising and lowering the water levels in Lake Ontario. The fluctuation in water levels will result in increased erosion damage to the shoreline, including the properties of businesses and homeowners; and

WHEREAS, Plan 2014 would also raise the current water maximum by 2.4 inches and will increase the annual cost of shoreline maintenance and protections by 13 percent. The plan offers no means of compensation to the stakeholders who will be negatively impacted by this man-made property damage; and

WHEREAS, the IJC received over 5,000 letters from organizations and constituents opposing the plan, yet the IJC has done nothing to address the negative impacts that increasing frequency of water level fluctuation will have on these communities; and

WHEREAS, the Plan spans six counties in Upstate New York and would cause damage to land assessed at nearly four billion dollars; and

WHEREAS, U.S. Representatives Chris Collins (NY-27) and John Katko (NY-24) jointly sent a letter to the House Committee on Appropriations Subcommittee on State, Foreign, Operations and Related Programs requesting language be included in the House Budget preventing any use of federal funding to implement LTC. Plan 2014; now be it

RESOLVED, that the Town Board of the Town of Canton supports NORA's initiative in supporting Congressman Collins fight to eliminate the IJC's ability to implement Plan 2014 which will provide certainty to the communities who have seen repeated efforts by the IJC to disrupt the current shoreline protections; and now be it
